AUTHORIZE PURCHASES OF LIFT GATE FOR 2022 DODGE RAM RECREATION DEPARTMENT TRUCK AND BASKETBALL POLE PADDING AT BOYCE PARK FROM PARKS CAPITAL RESERVE

WHEREAS, the Town of Dover Recreation Commission has approved an expense from Robert Green Truck Division for a lift gate for the Recreation Department's 2022 Dodge Ram 5500 in the amount of \$3,779 and an expense from BSN Sports for basketball pole padding for the courts at Boyce Park in the amount of \$979.98 to be paid from the Parks Capital Reserve.

NOW THEREFORE BE IT RESOLVED that the Town Board of the Town of Dover hereby authorizes an expense from Robert Green Truck Division for a lift gate for the Recreation Department's 2022 Dodge Ram 5500 in the amount of \$3,779 and an expense from BSN Sports for basketball pole padding for the courts at Boyce Park in the amount of \$979.98 to be paid from the Parks Capital Reserve.
