**RESOLUTION #0762025
AUTHORIZE TOWN SUPERVISOR TO EXECUTE AN INTERMUNICIPAL
AGREEMENT WITH DOVER UNION FREE SCHOOL DISTRICT (DUFSD)**

The following Resolution was offered by Councilwoman Jackson, seconded by Councilman Holmes, to wit,

WHEREAS, the Town of Dover is in need of an indoor location for its day camp and summer recreation programs in case of emergencies which would necessitate the use of indoor space for campers from June 30, 2025 through August 22, 2025; and

WHEREAS, the Dover Union Free School District has agreed to permit the Town of Dover to utilize the Dover schools under emergency circumstances pursuant to the terms of an intermunicipal agreement;

NOW THEREFORE BE IT RESOLVED that the Town Board of the Town of Dover does hereby authorize the Town Supervisor to execute an intermunicipal agreement with the Dover Union Free School District for the use of the Dover schools by the Town of Dover Summer Day Camp in the case of emergency situations; and

BE IT FURTHER RESOLVED that a copy of the fully executed intermunicipal agreement shall be kept on file in the Office of the Town Clerk.
