AUTHORIZE TOWN SUPERVISOR TO EXECUTE 2025-2026 AGREEMENT  
FOR NORTHEAST DUTCHESS TRANSIT SERVICE AGREEMENT (DIAL-A-RIDE)**

The following Resolution was offered by Deputy Supervisor Murphy seconded by Councilman Holmes,  
to wit,

**WHEREAS**, the Town of Dover has previously entered into a contract with the North East Community Center's (NECC) Northeast Dutchess Transit for transportation services so Dover citizens have access to medical care and other basic services.

**NOW THEREFORE BE IT RESOLVED** that the Town Board of the Town of Dover hereby authorizes the renewal of the NECC Northeast Dutchess Transit Contract for 2025/2026 and

**BE IT FURTHER RESOLVED**, that the Town Board of the Town of Dover hereby authorizes the Town Supervisor to execute the NECC Northeast Dutchess Transit, which contains no material changes from the previous years' agreement; and

**BE IT FURTHER RESOLVED**, that the Town of Dover shall pay NECC Northeast Dutchess Transit the sum of \$5,000.00 to cover the period of May 1, 2025 to April 30, 2026; and

**BE IT FURTHER RESOLVED**, that a copy of the contract shall be kept on file in the Office of the Town Clerk of the Town of Dover.


The Resolution was thereupon adopted on May 28, 2025.
